The SPIO has sent a Written Statement with today's date requesting for another date for hearing in view of his preoccupation with declaration of his technical bid results of e-tender.

The Petitioner, Sri Tasaduk Ariful Hussain is present.

Considering that the Appellant is present and the Respondent Public Authority has not apprised the Commission about the action taken, if any, to furnish the information, the Commission decided to conduct the hearing proceedings *ex parte*.

The Appellant submitted that the information he had sought for was important and urgent and that he is aggrieved that he has not received the information for over one year as against the time limit of 30 days provided for by the RTI Act, 2005. He pleaded for penal action against the defaulting Respondent. He added that although a hearing was held by the First Appellate Authority on his First Appeal dated 19.03.2018, he had not received any decision or order.

Considering that the RTI Application dates back to 07.02.2018 and the information has not been received by the Appellant, the **Commission hereby orders that the SPIO, office of the Assam Seeds Corporation Ltd. shall furnish the information sought for by the Appellant, free of cost, within 15 days of receipt of this order.**

The Second Appeal is hereby disposed of.
