<u>O R D E R</u> 06.05.2019

The parties are absent.

The SPIO has not submitted any Written Statement and has not explained as to why penalty U/S 20 (1) of the RTI Act, 2005 should not be imposed on him for his failure to furnish the information sought for within the time stipulated.

The First Appellate Authority/Circle Officer, Kaliabor Revenue Circle has not apprised the Commission about the steps he might have taken to dispose of the First Appeal in accordance with the RTI Act, 2005.

In the absence of the SPIO or any Written Statement from him, the Commission could not determine as to whether the notice for today's hearing i.e. notice no. SIC/NGN.206/2017/11 dated 11.04.2019 had been received by the respondents.

List the case for hearing in 5/6 weeks. The SPIO shall be personally present in the hearing with all relevant records and submit an explanation as to why penalty U/S 20 (1) of the RTI Act, 2005 should not be imposed on him for his failure to furnish the information sought for within the time stipulated.

As neither the SPIO nor the FAA have responded to the Commission's notice, the notice for the next hearing be served through the Sub-Divisional Officer (C), Kaliabor Sub-Division, Nagaon.
