The Appellant absent without information.

Perused the Written Statement and heard the SPIO. It has been submitted that the RTI Application dated 20.08.2016 was received on 26.08.2016 and transferred U/S 6 (3) of the RTI Act, 2005 to the SPIO of the Public Works (Road) Department through a letter dated 09.07.2018. A photocopy of a letter has been enclosed for evidence. The information sought for related to a Complaint dated 29.08.2015 submitted to the Chief Minister's Secretariat which was forwarded to the Commissioner & Special Secretary to the Government of Assam, Public Works (Road) Department through a letter dated 04.08.2015.

As the transfer of the RTI Application was not known to the Commission the Appropriate SPIO was not notified for today's hearing. The Commission was not informed of the transfer by the Appellant either.

Based on the submission by the SPIO, CM Secretariat, **the Commission hereby orders that the SPIO, Public Works (Road) Department, Government of Assam shall furnish the information to the Appellant, free of cost, within 10 days of receipt of this order, if not already done.**

The Second Appeal is hereby disposed of.
