Sri Yusuf Ali, SPIO/Asstt. Director of Agriculture and Sri Binoy Mudiari, APIO/Agricultural Dev. Officer are present. A Written Statement dated 11.04.2019 received from the District Agricultural Officer, Kamrup.

The Appellant/Complainant, Sri Utpal Das is present.

This hearing has been necessitated by the Complaint received from the Appellant that the SPIO had not complied with the Commission's order dated 03.03.2018.

Heard the Appellant/Complainant. He submitted that he had not received any response from the SPIO since submitting his Complaint.

Heard the SPIO and perused the Written Statement. He submitted that the relevant file could not be traced so far inspite of searches having been launched and the effort was still on. However, his office has taken up with the Deputy Commissioner, Kamrup (M) and also the authorities of the concerned Cement factory to obtain copies of the relevant documents. Some more time has been sought for tracing of the documents. The copies of the communication made in this regard have been enclosed for evidence.

From the submissions, it is seen that the matter was taken up with the concerned Company only on 30.03.2019, and that the matter has not been pursued with the DC's office after writing the letter dated 09.02.2018.

In view of the facts brought out above, **the Commission hereby directs the SPIO to obtain the relevant documents from the concerned Public Authorities such as Deputy Commissioner, Kamrup (M) and Industries Department as well as with the concerned Company to furnish the information as soon as possible and in any case within 21 days of receipt of this order. Besides, the District Agricultural Officer, Kamrup shall ensure that the relevant file is searched systematically and traced with a time-bound programme.**

The Complaint of non-compliance is hereby disposed of.
