**O R D E R**  
28.5.2019

1. The public authority is represented by the Under Secretary and SPIO of Home Department Shri Ramesh Medhi. The petitioner Shri Dulal Bora is absent. However, he has sent a written communication dated 28<sup>th</sup> May, 2019 stating that he has not got any information in response to his RTI petition dated 31.8.2016 following which the instant second appeal petition dated 24.7.2017 was filed. He has prayed for fixing another date for hearing his second appeal petition.

2. It is seen from the case records that the SPIO of Home Department requested the SPIO of Personnel Department to be present in today's hearing since the subject matter relates to Personnel Department. The SPIO of Personnel Department, though absent, sent a written statement dated 14<sup>th</sup> May, 2019. It is mentioned in the WS that the petitioner Shri Dulal Bora submitted two identical RTI petitions No. D.B-1530/16 dated 31.8.2016 and No. D.B-1379/16 dated 20.8.2016 referring to the same complaint petition vide letter No. D.B.70/1/15 dated 17.3.2015. The complaint petition related to allegation against Shri V.S. Bhaskar, IAS. The SPIO of Personnel Department enclosed copy of letter No. AAP.54/2015/Pt./15 dated 7<sup>th</sup> May, 2015 from the Deputy Secretary, Personnel Department furnishing the information to the petitioner Shri Dulal Bora for the action taken on his complaint petition dated 17.3.2015 referred to above. Since the petitioner submitted vide his WS dated 28<sup>th</sup> May, 2019 that he did not receive any communication from the concerned public authority, **the Registry of this Commission is directed to enclose a copy of Deputy Secretary, Personnel Department's letter No. AAP.54/2015/Pt./15 dated 7<sup>th</sup> May, 2015 along with this order for information of the appellant/petitioner.**

With the above order, the second appeal petition dated 24.7.2017 is disposed of.
