## <u>O R D E R</u> 29-5-2019

The petitioner Sri Durgeswar Das is absent. The Public authority is represented by Sri Dhiraj Das, Chief Accounts Officer, Nagaon Zilla Parishad is present.

The Chief Executive Officer Nagaon Zilla Parishad & the 1<sup>st</sup> Appellate authority has informed the Commission vide letter dt. 22-5-2019 that the RTI petition dt. 27-11-2017 was transferred to the BDO, Barhampur Development Block vide letter dt. 30-11-2017. On receipt of the 1<sup>st</sup> Appeal petition, hearing was fixed on 21-2-2018. The Appellant was absent and the Block Dev. Officer, Barhampur Dev. Block had requested the C.E.O. Nagaon Zilla Parishad to extend time to enable them to furnish the sought for information. The Appeal was disposed of with a direction to the SPIO, O/o the Barhampur Development Block to provide the information sought for by the petitioner free of cost within 15 days.

The Commission therefore directs the BDO, Barhampur Development Block to furnish the information sought for by the petitioner within 15 days from the date of receipt of this order.

With the above direction the  $2^{nd}$  Appeal petition dt. 22-2-2018 is disposed of.
