## <u>ORDER</u> 27-5-2019

# Seen the report of the registry that the e-mail sent by the petitioner Sri Rajen Pujari dt. 14<sup>th</sup> February, 2019 was not received by this office as the mail id was wrongly quoted as "sicassam @ gmail. com" instead of secretary, sicassam @ gmail.com. The appellant had prayed for exparte hearing stating that he would not be able to attend the hearing due to personal problem and that he had not received the sought for information from the concerned Public authority.

Seen the petition dt. 20-3-2019 submitted by the petitioner to re-look into the Order dt. 14-2-2019 in view of mail dt. 14-2-2019 sent by him as referred to above by the registry.

In the absence of the petitioner on 14-2-2019 and non-receipt of the e-mail referred to above the matter was disposed of by the Commission vide Order dt. 14-2-2019, based on the written statement of the SPIO & Joint Secretary, Pension & Public Grievances Deptt. that "as mentioned by the SPIO, Directorate of Pension, Assam, the information has already been furnished to the petitioner Sri Rajen Pujari, Golaghat."

In view of the above circumstances stated above since and the mail was sent by the petitioner on 14<sup>th</sup> February, 2019 the Commission directs the SPIO, Directorate of Pension to furnish the information sought for by the petitioner vide his RTI petition dt. 23-8-2018 within 21 days from the date of receipt of this order.
