ORDER

04.06.2019

- 1. The appellant Sri Dulal Bora is absent. He sent an e-mail dated 4.6.2019 praying for re-fixation of the date of hearing due to some personal problems. The public authority is present as represented by Dr. Bidyut Das Boro, APS, Addl. Superintendent of Police, Assam Police HQ, accompanied by ASI Paresh Borah.
- 2. Two separate written submissions dated 30.5.2019 and 1.6.2019 have been received from the Home Department requesting the DGP, Assam to send his representatives for today's hearing. Another WS dated 28.5.2019 has been received from the SPIO of Chief Secretary, Assam stating that the RTI application dated 9.8.16 as well as the first appeal petition dated 16.5.2017 were transferred to Home Department.
- 3. The ASPIO and Addl.DCP (Admn.), Guwahati submitted a copy of letter dated 6.8.2018 addressed to Sri Dulal Bora, appellant/petitioner, giving him the informations sought for vide his RTI petition No.DB 372/16 dated 30.7.2017. From perusal of the case records, it is seen that the instant RTI petition No.DB 945/16 dated 9.8.2016 is identical to the above mentioned RTI petition both with reference to the same Dispur PS Case No.1472/2014 under Section 420 of the IPC involving one Sri Hemen Das. Therefore, it seems to be another case of double/multiple RTI petitions and second appeal petitions filed by the same petitioner Sri Dulal Bora on the same subject. Since the sought for information was already furnished to him giving the Dispur PS case No., name of the investigating officer and that the above mentioned police case was taken up for re-investigation on the basis of the complaint filed by the petitioner, there seems to be no further cause of action and, therefore, further hearing of the instant second appeal petition dated 24.7.2017 is considered not necessary. However, since the last information was furnished nearly two years ago, the ASPIO of the office of the DGP, Assam is directed to inform the petitioner Sri Dulal Bora about the present status of the case under investigation within 15 days of this order which was pronounced in his presence.

4. With the above order, the second appeal petition dated 24.7.2017 is disposed of.
