O R D E R

1. The appellant Sri Dulal Bora is absent. He sent an e-mail dated 4.6.2019 praying for re-fixation of the date of hearing due to some personal problems. The public authority to be represented by the SPIO of Secretariat Administrative Deptt. is also absent. However, a written statement dated 28th May, 2019 has been received from the SPIO of the office of the Chief Secretary, Assam stating that the petitioner's RTI petition No. DB-825/16 dated 9.8.2016 and first appeal petition No.DB.50987/17/R/1 dated 16.5.2017 – both were transferred to the Secretariat Administration Deptt. for taking necessary action.

2. It is seen from the case records that the RTI petition was filed with reference to a complaint petition dated 17.6.2015 filed by Sri Dulal Bora before the Chief Secretary, Govt. of Assam against one Sri Pradip Gogoi. It was alleged by the complainant that Sri Pradip Gogoi who was an Upper Division Assistant in the office of the Chief Minister of Assam, was drawing salary inspite of being absent from duties for years together. By his RTI petition the complainant sought the following three informations :-

- (a) The number of the file from which enquiry was ordered into the allegation mentioned in his complaint petition dated 17.6.2015 and name of the Inquiry Officer with his designation;
- (b) Names and addresses of the persons mentioned in the complaint petition dated 17.6.2015;
- (c) Photocopy of inquiry report submitted by the Inquiry Officer to his higher authorities.

This Commission notes that the informations with regard to point No.2(b), i.e., names and addresses of the allegedly accused persons have been mentioned by the petitioner himself in his complaint petition dated 17.6.2015. Therefore, this part of the RTI petition appears to be redundant.

3. It appears from the case records that the sought for informations, which are admissible under RTI Act, 2005, have not yet been furnished by the concerned SPIO of SAD to the petitioner. The SPIO of SAD is, therefore, directed to furnish the informations against para 2(a) and 2(b) above to the petitioner within 15 days from the date of receipt of this order.

4. Giving the above facts and position of the second appeal petition and the order above, no further hearing of the second appeal petition is considered necessary at this stage. Accordingly, it is disposed of.
