O R D E R

31.05.2019

1. The appellant Sri Atikul Hussain is present. The public authority is represented by - (1) Sri Gautam Das, DTO, Kamrup, Amingaon, (2) Sri Utpal Gogoi, MVI & SPIO, and (3) Md. Ataur Rahman, Jr. Assistant. The second appeal petition dated 3.3.2018 is taken up for further consideration in pursuance of this Commission's earlier orders, the last one dated 22.4.2019.
2. The DTO and Secretary, RTA, Kamrup (R), Amingaon has submitted a written statement dated 27.5.2019, which is entered into the case records. The DTO has clarified that there is no record in his office on refusal to receive this Commission's notice by any of his employees. He has mentioned that the postal index no. in the address was wrongly written as 781039 instead of 781031. From the case records it is seen that the mistake was committed by the petitioner himself in his RTI petition.
3. As regards the subject matter of the instant second appeal petition, the appellant as well as the respondent submitted orally that the sought for information has been furnished and duly received by him. The appellant's only remaining grievance is that his application for registration of transfer of ownership of a private vehicle was pending for long 8 months. The DTO explained that this had happened before he took over. However, he clarified that the delay might have been caused by shifting of the office and office records from ground floor to the first floor of the DTO's office building. He assured that such delay will not happen in future. In view of the above assurance, it is decided to close the matter and disposed of the second appeal petition dated 3.3.2018.
