**O R D E R**

21.05.2019

1. The public authorities, i.e., the SDO (C), Rangia and Circle Officer, Rangia Revenue Circle are absent. However, both the SDO (C) and the Circle Officer sent two separate written communications dated 20.5.2019 praying for re-fixation of the date of hearing on the ground that they have been appointed as Assistant Returning Officer and District Election Officer, and ARO respectively for No.8 Mangaldoi Lok Sabha Constituency. The Deputy Commissioner (R), Amingaon and the first appellate authority has also sent a separate written statement dated 17.5.2019, which is entered into the case records. It has been mentioned in the FAA's WS that he heard the first appeal petition dated 11.2.2019 and passed order on 4.3.2019 directing the SDO (C), Rangia to furnish the information received from the Circle Officer, Rangia Revenue Circle vide letter No. RC-1/2019/5 dated 19.1.2019 directly to the petitioner within 15 days from the date of receipt of his order. The FAA has also mentioned that accordingly the SDO(C) furnished the sought for information to the petitioner vide letter dated 18.3.2019. The petitioner also acknowledged receipt of the sought for information in response to his RTI petition dated 27.12.2018 with reference to which the instant second appeal petition dated 5.3.2019 was filed. His only remaining prayer with regard to the documents furnished to him is that they were not certified and/or attested as true copies by the concerned revenue officials. The appellant is, therefore, directed to approach the SPIO of the office of the SDO (C), Rangia within 15 days from 25<sup>th</sup> May, 2019 for getting the documents furnished to him, as mentioned above, duly attested as true copies with seal and signature of the concerned revenue officials. The SDO (C), Rangia is directed to instruct the concerned officials to do such certification/attestation accordingly within the time limit mentioned and report compliance to reach this Commission on or before 30<sup>th</sup> June, 2019. The appellant is also directed to inform the Registry of this Commission after he is fully satisfied with the action taken by the office of the SDO (C), Rangia.

2. Fix 24.6.2019 for review of compliance. Fresh date of hearing will be fixed, if necessary, after the review.
