**O R D E R**

29.05.2019

1. The appellant Sri Shyamal Kumar is present. The respondent i.e. the SPIO of the Court of Munsiff No-2 is absent without any information. On the last date of hearing i.e. 3.5.2019 also he was absent without any information, though notice was duly served by the Registry of this Commission. The second appeal petition dated 17.02.2018 read with the RTI petition dated 24.10.2017 is taken up for consideration ex-parte in the absence of the respondent.

2. The appellant Sri Shyamal Kumar submitted orally that he has not received any information so far from the concerned SPIO in reply to his RTI petition. However, from perusal of his RTI petition it appears that the subject matter of the instant RTI petition dated 24.10.2017 is a disputed land sale deed. The same petitioner filed another RTI petition dated 19.9.2019 followed up by first appeal petition dated 07.11.2017 and a second appeal petition dated 27.1.2018 in connection with the same allegedly disputed land sale deed. That second appeal petition was disposed of by a speaking order today, dated 29.5.2019, in second appeal case No.-SIC/KP(M).414/2018. So far as the instant second appeal case is concerned, the petitioner apprised this Commission orally that a civil court case involving the said allegedly disputed land sale deed is under adjudication in the Court of Munsiff No-2 Kamrup(M) District. This Commission is of the view that the appellant should seek the informations mentioned in his RTI petition dated 24.10.2017 in pursuance of relevant rules notified by the Hon'ble Gauhati High Court.

3. The SPIO of the Court of Munsiff No-2 Kamrup(M) District is, therefore, directed to give appropriate reply to the appellant in response to his RTI petition dated 24.10.2017 within 15 days from the date of receipt of this order with intimation to the Registry of this Commission.
