- 1. The petitioner Sri Dulal Bora is absent. He has sent an e-mail dated 10th June, 2019 praying for re-fixation of the date of hearing as he is unable to attend today's hearing due to some personal problems.
- 2. The Under Secretary and SPIO of Home Department, Govt. of Assam sent copy of the letter dated 24th May, 2019 addressed to the SPIO of the Office of the DGP Assam requesting him to attend today's hearing. Dr Bidyut Das Boro, APS, Additional SP, (Law) APHQ is present accompanied by Sri Paresh Borah, ASI of the DGP's office. The Deputy Inspector General of Police (L &O) sent a copy of his letter dated 1.6.2019 addressed to Sri Dulal Bora furnishing him informations about Basistha PS Case No. 405/2015 that was registered in pursuance of the petitioner Sri Dulal Bora's complaint petition dated 17.3.2016.
- 3. However, as noted in para 2 of this Commission's order dated 7.5.2019 the aforesaid complaint petition had four (4) parts. The DIGP's letter dated 1.6.2019 mentioned above does not specify which part of the complaint was registered as the police case referred to above. Nor has it mentioned the position in regard to the other three (3) parts of the complaint petition. The SPIO of the office of the DGP is, therefore, directed to clarify the above, by giving a written statement on or before the next date of hearing.
- 4. Fix 16th July, 2019 at 12.30 PM for next hearing.
- 5. Issue notices to both the parties accordingly.
