O R D E R

11.06.2019

- 1. The petitioner Sri Thaneswar Deori is present accompanied by Sri Pranjal Deori. The public authority is represented by Sri Sanju Kr. Deori, Jr. Assistant of the Deori Autonomous Council as authorized by the Principal Secretary of the Deori Autonomous Council.
- 2. Being the first time, the representation of the Deori Autonomous Council at junior assistant level is allowed with the direction that in future, concerned Principal Secretary shall depute a senior functionary like Assistant Engineer or Subordinate Engineer or Head Assistant, etc., for appearing before this Commission, if he cannot attend himself.
- 3. The second appeal petition dated 26.12.2018 read with RTI petition dated 18.7.2018 is taken up for hearing in presence of both the parties.
- 4. The Principal Secretary of Deori Autonomous Council sent a written submission dated 10.6.2019 through his authorized representative stating that the informations sought for by the petitioner by his RTI petition dated 18.7.2018 could not be furnished within the stipulated time limit due to non-cooperation of the Council's office staff for not getting their monthly salaries. The Principal Secretary further mentioned in his WS that the required informations have now been prepared and sent with the authorized representative for handing over the same to the petitioner.
- 5. With permission of this Commission, the DAC's authorized representative handed over the documents to the petitioner and obtained acknowledgement receipt of the same.
- 6. It is seen that the informations furnished is very voluminous. The Principal Secretary, DAC is advised that in case of such voluminous information he can, in future, request the information seekers to exercise their right to information by way of inspection of records and documents as provided under Section 2(j)(i) of the RTI Act, 2005.

7. In view of the above, the second appeal petition dated 26.12.2018 is disposed of with the rider that the petitioner will be at liberty to revert back to this Commission if after going through the informations furnished seem to be incomplete or incorrect.
