ORDER

- 1. The appellant Sri Mohan Chandra Poddar is present. The public authority, the SPIO of Gauhati University is absent. However, he has sent a written communication explaining the reasons for his inability to attend today's hearing and authorizing Sri Tridip Kalita, attached to the PIO to be present in today's hearing. He has also sent a separate written statement dated 29.5.2019 with supporting documents stating that the information sought for by the petitioner by his RTI petition dated 18.12.2018 was furnished vide letter dated 2.1.2019. He enclosed with the W/S photocopies of the relevant GU notification dated 1.6.2017 laying down the procedure for re-evaluation of answer scripts of the student. It is also mentioned that the petitioner filed another RTI petition dated 5.1.2019 which was also replied vide letter 24.1.2019. In his application dated 5.1.2019 the petitioner mentioned receipt of the notification dated 1.6.2017 mentioned above, but he raised another point, - whether the reexaminer appointed by the University authority does the re-evaluation of the answer script by hiding the previous marks by the previous examiner. On this point the authorized representative of GU furnished a copy of the letter dated 30.5.2019 addressed to the PIO/Dy Registrar by the Controller of Examination clarifying that the re-evaluation step (i.e., third step) is followed by appointing an alternative examiner than earlier/original examiner to evaluate the answer script after covering the marks given by the original examiner. The PIO of GU is directed to furnish a copy of this communication to the petitioner today and obtain receipt in acknowledgement thereof.
- 2. With the above order, the second appeal petition dated 22.2.2019 is disposed of.
