**O R D E R**

02.07.2019

1. The petitioner Sri Abhinandan Kashyap is absent. However, he is represented by his father Sri Niren Deka as authorized by the appellant by a letter dated 2.7.2019. The public authority, i.e., APDCL is also present as represented by (i) Sri S.N. Ahmed, DGM (Law), (ii) Sri B. Baruah, AGM (Law) and (iii) Smti. D.Chutia, AM (Law). The second appeal petition dated 28.3.2019 is taken up for hearing in presence of both the parties. The SPIO of APDCL has submitted a written statement dated 1.7.2019 which is entered into the case records.
2. From perusal of the case records it is seen that the petitioner filed an RTI petition dated 1.2.2019 before the SPIO of Assam Power Distribution Company Limited (APDCL). The subject matter of the RTI petition is a selection test conducted by the APDCL to fill up few posts of Assistant Manager (Civil). For this purpose an online examination was conducted on 25.11.2018 by APDCL. The RTI applicant was also a candidate, belonging to general category with Roll No.5001007. He sought the following informations :-
  - (i) No. of defective questions in the said online examination;
  - (ii) Total marks allotted against the defective questions, and
  - (iii) The RTI applicant's position in the merit list (general) on the basis of his score in the response sheet.
3. It is also seen from the second appeal petition that the RTI applicant was already furnished a copy of his response sheet. But no specific response has been given against the three points raised by the appellant in his RTI application. The SPIO of APDCL is, therefore, directed to give specific replies against the above three points, i.e., 2(i), 2(ii) and 2(iii) mentioned above within 15 days from the date of receipt of this order.
4. With the above order, the second appeal petition dated 28.3.2019 is disposed of.
