**O R D E R**

The petitioner Shri Mukuteshwar Goswami as well as the public authority to be represented by the SPIO of Anundoram Borooah Institute of Language, Art and Culture (ABILAC) – both are absent without any information. Hence, the second appeal petition dated 27.2.2018 read with RTI petition dated 31.10.2017 is taken up for consideration ex parte in the absence of both the parties.

On the last date of hearing i.e. on 13.5.2019 also both the parties were absent. However, the PIO of ABILAC sent a written request dated 8.5.2019 praying for three weeks' time to enable him to prepare his written statement for submission before this Commission. No written statement been received from the ABILAC and no representative from ABILAC was present at the time of today's hearing. The SPIO of ABILAC is directed to furnish the informations sought for by the petitioner vide his RTI petition dated 31.10.2017 within 15 days from the date of receipt of this order with intimation to this Commission in compliance with provision of section 7 (1) of the RTI Act, 2005. If for any of the reasons specified under section 8 and 9 of the RTI Act, 2005, the sought for informations, or any part thereof, cannot be provided, then the informations seeker be informed accordingly specifying the reasons for rejection of the request, within 15 days from the date of receipt of this order. If no SPIO has been appointed by the ABILAC so far, then the Director of ABILAC will be deemed to be the SPIO of the institution in exercise of powers conferred u/s 19(8)(ii) of the RTI Act, 2005.

With the above orders, the second appeal petition dated 27.2.2018 is disposed of.
