> <u>O R D E R</u> 12.6.2019

The petitioner Shri Joydeb Das is absent. He has sent an e-mail dated 12<sup>th</sup> June, 2019 stating that he is unwell and not in a position to attend today's hearing. He prayed for re-fixation of the date of hearing. The public authority, i.e A.H. & Vety Department, Government of Assam is present as represented by the Joint Secretary and SPIO Smti. Dipalee Devi. She has filed a written statement dated 6.6.2019 with enclosures. It has been mentioned in the WS that the informations sought for by the petitioner vide his RTI petition dated 9.7.2018 were already furnished to him vide letters dated 13.8.2018 and 7.12.2018. Copies of informations furnished have been enclosed with the WS. However, in the second appeal petition dated 12.10.2018 filed by the petitioner, he made no mention of the above two communications. The second appeal petition has been filed on the ground of nor furnishing of the sought for informations. This Commission is of the view that the informations furnished substantially addressed the RTI petition.

In view of the above, the SPIO and Joint Secretary of A.H. & Vety. Department is directed to furnish copies of letters dated 13.8.2018 with enclosures and letter dated 7.12.2018 to the petitioner by registered post within 15 days from the date of this order.

With the above order the second appeal petition dated 12.10.2018 is disposed of with the provision that after receipt of the informations, if the petitioner is not satisfied, he will be free to seek clarification from the SPIO concerned or approach this Commission for further orders.
