Since the contents of the letter appear to have provided present position of the issues raised and informations sought for by the petitioner Shri Dulal Bora, vide his RTI petition dated 15.9.2016, the letter dated 9th July, 2019 appears to be fully responsive to the RTI petition dated 15.9.2016. If the petitioner Shri Dulal Bora needs any further clarification, then he is directed to revert to this Commission within 15 days from the date of receipt of this order, failing which it will be presumed that he is satisfied with the informations furnished to him. With this order the second appeal petition dated 24.7.2017 is disposed of.
