**O R D E R**

12.07.2019

1. The respondent, i.e., the APDCL is present as represented by Smti Monalisha Bhattacharyya. The complainant is absent. However, he informed the Registry of this Commission telephonically that while coming to this Commission's office to attend the today's hearing in the instant second appeal case, he met with an accident. So he could not attend. He further informed telephonically, as reported by the Registry of this Commission, that he is not interested in pursuing the instant case any more.
2. The SPIO/DM(HR), APDCL submitted a written statement dated 9.7.2019 which is entered into the case records. It has been mentioned in the WS that by his RTI petition dated 13.6.2018 the petitioner requested for third party informations. While the SPIO of APDCL contacted the third parties, they refused to give their consent for disclosure of those informations. The RTI applicant was informed accordingly. A copy of the peon book where the applicant received the information has been furnished with the WS. In this connection it is noted that by this Commission's order dated 10.7.2019 the same petitioner Sri Satya Prasad Barua was furnished details of all the 16 electricity consumers in Aftab Market Complex building including the two parties mentioned in the instant second appeal case and RTI petition. Today the SPIO of APDCL submitted before this Commission another statement showing the connected loads and power consumption by the two consumers, one owning a hair cutting saloon in the ground floor ( G. Mustafa) and the other owning the advertisement hoardings on the top of the building ( Ubedur Rahman).
3. Although the appellant of this second appeal petition has expressed his disinterestness in pursuing his instant complaint petition dated 4.12.2018 read with RTI petition dated 13.6.2018, since the SPIO has furnished the sought for informations, a copy of the same be enclosed with the complainant's copy of this order so as to facilitate final closure of the matter.
4. With the above order the complaint petition dated 4.12.2018 is disposed of.
