> ORDER 16.7.2019

1. The petitioner Sri Mukul Chetia is absent without any information. The public authority to be represented by the Directorate of Accounts and Treasury, Govt. of Assam, is present as represented by Sri Premananda Hazarika, Sr. Finance and Accounts Officer and SPIO of the office of the Directorate of Accounts and Treasury (DoAT) accompanied by Smti. Anjuman Ara Begum, Sr. Asstt. of the Directorate.

The SPIO has sent a written statement dated 16th July, 2019, which is entered 2. into the case records. It is seen from the enclosed documents of the written statement that the petitioner Sri Mukul Chetia's RTI petition dated 7.6.2018 was transferred by the SPIO of Directorate of Accounts and Treasury to the Deputy Secretary of Govt. of Assam, Judicial Department under section 6(3) of the RTI Act, 2005. That information was furnished to the petitioner vide letter No. DA.105/2012/Pt-II/226 dated 30.6.2018. This was reiterated by subsequent letter dated 18th August, 2018. The SPIO of DoAT could not ascertain whether the Judicial Department, Govt. of Assam furnished the sought for information to the petitioner. In the absence of the petitioner at the time of today's hearing this Commission also could not ascertain what is the present position in this regard. After the transfer of the RTI petition the Judicial Department being the concerned public authority, the SPIO of Judicial Department is, therefore, directed to furnish the sought for informations to the petitioner within 15 days from the date of receipt of this order with intimation to Registry of this Commission. The SPIO of DoAT is also directed to send a copy of the RTI petition once again to the SPIO of Judicial Department immediately for their ready reference.

3. With the above order, the second appeal petition dated 15.12.2018 is disposed of.
