**O R D E R**

30.08.2019

1. The appellant Sri Debabrata Banerjee is present. The public authority, i.e. Assam Higher Secondary Education Council is represented by Sri Palin Chandra Das, Assistant Secretary (Admn.). The complaint petition dated 29.4.2019 is taken up for hearing in presence of both the parties.
2. From perusal of the case records it is seen that the appellant Sri Debabrata Banerjee filed an RTI petition dated 23.2.2019 before the SPIO of Assam Higher Secondary Education Council (AHSEC) seeking informations regarding recruitment test for the posts of Junior Assistants in the Council, the written examination of which was held on 16.9.2018. The SPIO of AHSEC submitted a copy of his letter dated 3.4.2019 addressed to the appellant Sri Debabrata Banerjee informing him that the advertisement for the posts of Junior Assistants was published in "more than 2 local newspapers". The written examination for the said post was conducted on 16.9.2018, in which 18739 candidates appeared. Since the selection process has` not been completed till date, no information could be provided. The information already furnished to the appellant, as above, appears to meet the requirement of point no.1 of the RTI petition.
3. As regards points no.2 and 3, the Asstt. Secretary of AHSEC made a written submission that the final results of the recruitment test is yet to be announced, therefore, the sought for information cannot be disclosed at this stage. This Commission is also of the view that it may not be appropriate to disclose the sought for informations against points no.2 and 3 before declaration of final results.
4. With the above observations, the complaint petition dated 29.4.2019 is disposed of.
