The appellant/petitioner Sri Kuldip Singh is absent without any information. The public 1. authority is represented by Deputy Registrar, Kamrup (M) District Sri Pankaj Kumar Sarma accompanied by Sri Sunil kr. Medhi, SI of Panbazar Police Station. The ASPIO of the office of the Deputy Commissioner, Kamrup (M) submitted a written statement dated 31.7.2019 stating that the required informations had already been furnished to the petitioner. The Deputy Registrar Sri Pankaj Kumar Sarma submitted that this case is related to the other second appeal case No. SIC/KP(M)/447/2019. The land sale deed involved in the case no.SIC/KP(M)/447/2019 could not initially be traced out and was thought to be missing. Therefore, an FIR was lodged by the Deputy Registrar with the O.C., Panbazar PS vide letter dated 5.12.2016. Copy of the FIR along with investigation report mentioned in the RTI petition were already furnished to the petitioner vide letter dated 1<sup>st</sup> April, 2019. Moreover, after filing the FIR the relevant sale deed was found and the copy of the same was furnished to the petitioner as already recorded in today's order in second appeal case No. SIC/KP(M)447/2019.

2. In view of the above, there seems to be no further cause of action so far as the instant second appeal case is concerned, and hence, the second appeal petition dated 4.1.2019 is disposed of.
