O R D E R

28.08.2019

1. The appellant Sri Narendra Siotia is absent without any information. The public authority, i.e., the SPIO of the office of the Deputy Commissioner, Kamrup (M) is also absent. However, he sent a prayer dated 27.8.2019 stating that due to pre-occupation of the SPIO and the deemed PIO who are engaged in the publication of the final NRC scheduled on 31.8.2019, they were unable to attend today's hearing. The SPIO also sent another written statement dated 27.8.2019 giving details of action taken on the petitioner's RTI petition dated 18.1.2019 followed by first appeal petition dated 25.2.2019 and the instant second appeal petition dated 26.4.2019. It is seen from the WS and the attached papers that the FAA-cum-Deputy Commissioner, Kamrup (M) passed an order dated 10.7.2019 directing the Addl. Deputy Commissioner, Land Settlement Branch to provide the required informations to the appellant within 1.8.2019. A copy of the Circle Officer, Guwahati Revenue Circle's letter dated 6.8.2019 addressed to Sri Narendra Siotia was also attached with the WS. By this letter the Circle Officer furnished the required informations to the petitioner. However, it could not be made out whether the copy of Receipt No.1012 dated 25.4.2018 was furnished to the petitioner. If the petitioner has not received copy of this document and he is still in need of it, then he is directed to collect the same from the office of the Circle Officer, Guwahati Revenue Circle within 15 days from the date of this order, copy of which be given also to the Circle Officer. The Circle Officer is also directed to comply with this order.

2. This Commission also notes that the second appeal petition was dated 26.4.2019, quite a few months before furnishing of the information by the Circle Officer following the order of the FAA.

3. In view of the above, there seems to be no further cause of action so far this Commission is concerned and hence the second appeal petition dated 26.4.2019 is disposed of with the above orders.
