**O R D E R**  
31.7.2019

1. The appellant Shri Rituparna Bora is present. The public authority to be represented by the SPIO of Karbi Anglong Autonomous Council, Diphu is absent without any information. The second appeal petition dated 16.11.2018 read with the RTI petition dated 15.2.2018 is taken up for consideration ex parte in the absence of the public authority.

2. From perusal of the case records it is seen that the petitioner Shri Rituparna Bora sought informations against 7 (seven) points relating to construction of rooms/ complexes/buildings by Diphu Town Committee during the period 2000-2017. He stated in his second appeal petition and also submitted orally today that till date no information has been furnished to him by either Diphu Town Committee or the Karbi Anglong Autonomous Council. From perusal of the RTI petition it is seen that the sought for informations are admissible under the RTI Act, 2005, although they will be voluminous – covering several issues over a period of 17 years.

3. The SPIO of Karbi Anglong Autonomous council is, therefore, directed to furnish the required informations to the petitioner free of cost upto 100 pages and thereafter against payment of Rs. 2.00 for every additional page of photocopy that he requires. If any such additional fee is required to be paid by the petitioner, then the SPIO will inform the petitioner of the amount thereto with breakup within 30 days from the date of receipt of this order and he will furnish the sought for documents within additional 45 days from the date of receipt of additional fee.

4. The appellant submitted that he would like to personally collect the sought for documents. The SPIO is directed to handover the documents after payment of required fee as ordered above personally to the appellant.

With the above order, the second appeal petition dated 16.11.2018 is disposed of.
