**O R D E R**

13.8.2019

1. The petitioner Sri P.K. Sarmah is present accompanied by Sri Jatindra Nath Borah and Sri Amrit Goswami to assist him. The public authority is represented by Sri Pankaj Choudhury, Zonal Engineer and deemed PIO of Guwahati Municipal Corporation (GMC). The second appeal petition dated 19.2.2019 read with subsequent prayer dated 10.6.2019 is taken up for hearing in presence of both the parties.
2. The PIO of Guwahati Municipal Corporation has submitted a written statement dated 9.8.2019 which is entered into the case records. The Associate Planner of GMC has also submitted a separate written statement dated 9.8.2019. This was also entered into the case records. The deemed PIO and Zonal Engineer of GMC present today submitted orally that building permission in a plot of land having Patta No. 38 and Dag No. 1055 was issued by GMC in favour of one Sri Shyam Sundar Agarwalla. No building permission was granted against the names mentioned in the RTI petition dated 19.11.2018. The deemed PIO has submitted that he has meanwhile collected the sought for informations from the concerned Associate Planner and the same are ready for handing over to the appellant/ petitioner.
3. In view of the above, the appellant is directed to collect the required informations personally from Sri Pankaj Choudhury, Zonal Engineer and deemed PIO of GMC during office hours on any working day within 7 days from the date of this order which was pronounced in presence of both the parties.
4. With the above order, the second appeal petition dated 19.2.2019 is disposed of.
