## ORDER 16.8.2019

1. The petitioner Sri Gunjan Pratim Dutta is present. The public authority is represented by Director of Research (Veterinary) Dr. Niranjan Kalita, accompanied by-(i) Dr. Deben Sapcota, Professor & Head, Department of Poultry Science, CVSC, Khanapara, (ii) Dr. Birendra Nath Bhattacharyya, Deputy Director of Research (Vety.) and (iii) Indranil Kalita, Advocate of Gauhati High Court. The second appeal petition dated 27.2.2019 read with the RTI petition dated 8.11.2018 is taken up for hearing in presence of both the parties.

2. The Director of Research (Vety) has submitted a written statement dated 14.8.2019 with relevant enclosures which is entered into the case records. It has been mentioned in the written statement that the RTI petition dated 8.11.2018 was responded to vide letter dated 1.12.2018 informing the petitioner that although the Directorate does not conduct any TSP Programme directly, but through different organizations as and when necessary. The sought for informations can be furnished if the RTI applicant specifies the years for which he wants the information. There were further correspondence between the RTI appellant and the Director centering basically around the same issue. The appellant submitted orally that he has meanwhile informed the Directorate of Research (Vety) of AAU about the years for which he wants the informations. The concerned Director is, therefore, directed to furnish the informations for those years in respect of organizations through which they conduct TSP programme within 30 days from the date of this order which was pronounced in presence of both the parties.

3. With the above order, the second appeal petition dated 27.2.2019 is disposed of.
