<u>ORDER</u>

19.8.2019

- 1. The petitioner Sri Shazzad Hussain is present. The public authorities, i.e. the SPIO of the office of the Superintendent of Police Goalpara Sri Amitabh Basumatary, Additional SP Headquarter, and Sri Ramesh Medhi, Under Secretary and SPIO of Home Department are present. The second appeal petition dated 14.3.2019 read with the RTI petition dated 3.1.2019 is taken up for hearing in presence of both the parties. The Under Secretary and SPIO of Home Department submitted that the first appeal petition was not received in the department.
- 2. From perusal of the case records, it is seen that the RTI applicant vide his RTI petition dated 3.1.2019 wanted copy of form No. 54 under section 150 (a) and (b) of MV Act, 1988, i.e. Accident Information Report in connection with the Krishnai Police Station Case No. 123/2018 under section 279/338/304(A) IPC vide GDE No. 77 dated 4.5.2018. The Additional SP and SPIO submitted that copy of the GD entry had already been furnished to the appellant. As regards form No. 54, the Additional SP submitted that copy of this document has to be given to the complainant mandatorily within 15 days from the date of receipt of the complaint and accordingly it must have been given to the complainant. However, the appellant submitted that the complainant had not yet received copy of form No.54 which is a public document.
- 3. In view of the above, the Additional SP Headquarter and SPIO of the office of the SP Goalpara is directed to verify his office records and inform the RTI applicant the date and the person to whom the form No. 54 was sent, and also obtain a copy of the same from the concerned MACT Tribunal and furnish it to the RTI applicant within 15 days from the date of receipt of this order which was pronounced in presence of both the parties.
- 4. With the above order, the second appeal petition dated 14.3.2019 is disposed of.
