**O R D E R**

22.8.2019

1. The appellant Sri Joydeb Das is present. The public authority to be represented by the SPIO of Director of Secondary Education, Govt. of Assam is absent. However, he sent a written statement dated 21.8.2019, which is entered into the case records. It is stated in the written statement that the sought for informations as available in the Directorate was sent to the petitioner vide letter dated 19.8.2019, copy of which was enclosed with the written statement. It is seen that the informations furnished contain the comparative statement and minutes of the tender evaluation meeting finalizing the price of ladies bicycle for the year 2018-19.
2. The appellant submitted orally that he has not yet received the above mentioned communication. The Registry of this Commission is directed to provide the copy of the above document to the petitioner.
3. The appellant by his RTI petition dated 14.12.2018 sought for two more remaining informations:-
  - (a) Copy of the work order given to the supplier, and
  - (b) Copy of prevailing market verification report prior to selection of contract awarded,
4. The above two informations are admissible informations under the RTI Act, 2005 provided they exist. The SPIO of the Directorate of Secondary Education is, therefore, directed to furnish the above two informations to the petitioner within 15 days from the date of receipt of this order, provided supply order was actually given to the selected bidder and if market verification report of the prevailing prices of the bicycle was carried out before awarding the contract. If the above two informations do not exist, then the petitioner may be advised accordingly with the reasons thereof.
5. With the above order, the second appeal petition dated 27.3.2019 is disposed of.
