ORDER 26.8.2019

1. The petitioner Sri Syed Ali Ahmed is absent without any information. The public authority, i.e. the Guwahati Municipal Corporation (GMC) is represented by Sri Anuj Kr. Talukdar, Assistant Engineer, Planning Branch of GMC accompanied by Sri Priyanshu Prawal Thakuria, Town Planning Specialist and Zonal Engineer of Planning Branch of GMC. The second appeal petition dated 15.3.2019 read with the RTI petition dated 13.12.2018 is taken up for consideration ex-parte in the absence of the petitioner.

2. The SPIO of GMC has submitted a written statement dated 26.8.2019 which is entered into the case records. It has been mentioned in the written statement that after collection the required informations from the Associate Planner of GMC, the same was sent through speed post vide letter dated 28.5.2019 to the petitioner in the given address but the postal authority returned the speed post with the comment that the petitioner had left the premises. The SPIO enclosed with his written statement copy of his letter dated 28.5.2019 along with copy of file note sheet and other informations sought for by the petitioner.

3. In view of the above, there seems to be no further cause of action so far as this Commission is concerned. If the RTI applicant is still interested he may personally contact the PIO of GMC during office hours on any working day within 15 days from the date of receipt of this order and collect a copy of PIO's letter dated 28.5.2019.

4. With the above order, the second appeal petition dated 15.3.2019 is disposed of.
