**O R D E R**

24.07.2019

Sri Pradip Sarma, SPIO/Secretary, Housefed and Sri Mrinal Saikia, ASPIO, Housefed, Guwahati are present.

The Appellant, Sri Harinarayan Pathak is present.

Perusal of the case record indicates that the Appellant had submitted his Second Appeal being aggrieved that the information furnished to him was incomplete and unsatisfactory. He had detailed the three grounds in his First Appeal as to why he was not satisfied. The Managing Director, Housefed/First Appellate Authority had issued an order on the First Appeal stating that the information furnished appeared to be complete. In his Written Statement dated 18.07.2019, the MD, Housefed submitted that the First Appeal dated 30.07.2018 was heard on 30.08.2018 at 3:30 PM in which the Appellant was present. He reiterated the fact that the SPIO had furnished the information.

Heard the Appellant. He submitted that the order of the FAA was not based on facts for the reason that the hearing did not actually take place as the FAA was himself absent while he (the Appellant) was present in the office for the purpose as notified. He further explained the three grounds he had mentioned in his First Appeal for his considering the information incomplete. As the first ground he had submitted that no file notings from 19.12.2017 to the date of his Application was furnished to him.

Heard the SPIO. He submitted that there were no more file notings after the said date of 19.12.2017 relating to the documents whose copies he had sought for. The Appellant stated that he would be satisfied if he would receive this position in writing. Regarding the other two grounds that related to copies of documents referred to in the file notings and improper authentication of copies of documents furnished to the Appellant, the SPIO submitted that matter could be reviewed.

In view of the facts brought out above, **the Commission hereby orders that the SPIO shall assure the Appellant in writing regarding there being no file notings after the said date of 19.12.2017, and furnish authenticated copies of documents if any mentioned by**

**the Appellant in his First Appeal, and ensure that all copies of documents furnished are duly authenticated.**

**With this, the Second Appeal is hereby disposed of.**
