The Commission therefore hereby directs the said BEEO to take necessary action in this regard and to ensure that a SPIO is designated and duly notified for the information of the public in accordance with Section 5 (1) of the RTI Act, 2005. Likewise, he is directed to designate an officer as the FAA U/S 19 (1) of the said Act which could be himself, and display their respective name(s) and designation(s) prominently in public interest.**
