O R D E R

The petitioner Sri Durgeswar Das is absent. The public authority is represented by Smti Momita Das Rahang, BDO Dolongghat assisted by Smti Sikha Gogoi, Extension Officer and SPIO Dolongghat Development Block. The BDO has furnished a copy of the letter issued by the then BDO dated 27.11.2017 informing the petitioner that the records and documents sought for by him were available in the office of the BDO and he could contact the then accountant Sri Barun Ch. Bordoloi and collect the documents after payment of photocopy charge @ Rs. 2.00/- per page. She submitted orally that that the petitioner Sri Durgeswar Das had submitted eight (8) numbers of RTI petitions on the same date dated 6.10.2017 before the BDO Dolongghat (Morigaon district). He had filed another eight (8) numbers of RTI petition on the same date dated 6.10.2017 before the BDO Dolongghat (Nagaon district). She also submitted that the petitioner neither visited their office not communicated with them after that.

In view of the above, the Commission directs the petitioner to visit the office of BDO Dolongghat for inspection of records relating to "Const. of CC Block rd. from Putukon Bordoloi House to JTB PWD Rd. via Santipur Namghar (Ph-II)" within 21 days from the date of receipt of this order and complete inspection of documents during office hours. The petitioner will give atleast 2 days notice to the public authority for inspection of documents.

The BDO Dolongghat is, also directed to allow the petitioner to inspect the relevant records and documents as mentioned above and allow him to take notes and photocopies of the sought for documents free of cost upto 20 pages and thereafter on payment of Rs. 2.00/- for every additional page of photo copy.

With the above direction, the second appeal petition dated 30.1.2018 is disposed of.
