The petitioner Sri Harinarayan Pathak is present. The public authority is represented by Brig Joshi Narain Dutt (Retd.), SPIO of the Directorate of Sainik Welfare accompanied by Col. Dayal Chardia Kakati (Retd.), Nodal Officer of the Directorate of Sainik Welfare and Sri Anuj Kr Das, Superintendent of the Directorate.

The Director of Sainik Welfare Assam had submitted a written statement dated 18th July, 2019 with copy to the Deputy Secretary and SPIO of General Administration Department and the petitioner. The petitioner vide letter dated 26.7.2019 sought for a copy of the same which was furnished to him.

The petitioner submitted a rejoinder on 5.8.2018 that on perusal of annexure B, it was found that information furnished was incomplete. A copy of the rule as mentioned therein had not been furnished and the continuous note sheet provided by the public authority did not mention SI No. 52 to SI No. 166. The public authority present stated that SI No. 52 to SI No. 166 were not related to the amount of Rs. 10,00,000.00 lakhs as mentioned in the RTI petition and hence, all other SI Nos. related to the amount of Rs. 10,00,000.00 lakhs had been furnished. However, they agreed to furnish SI No. 52 to SI No 166 of the continuous note sheet and copy of the rule as sought for by him. The petitioner stated that he would be satisfied if the public authority would furnish the aforesaid documents.

The Commission therefore, directs the public authority to furnish the aforesaid documents within 10 days from the date of receipt of this order

With the above order, the second appeal petition dated 21.7.2018 is disposed of.
