The petitioner Sri Durgeswar Das is absent without any information. The BDO Moirabari Development Block has authorized Sri Jitendra Nath, Accountant, Moirabari Development Block to attend the hearing on behalf of Sri Jagdish Das, SPIO and J.E Moirabari Development Block as he has engaged in flood duty.

The representative of public authority informed the Commission that the RTI petition filed by Sri Durgeswar Das was transferred to the Moirabari Gaon Panchayat vide letter dated 31.10.2017 directing him to furnish the information to the petitioner directly. He also submitted that he had contacted the Secretary of Moirabari Gaon Panchayat over telephone and the Secretary had informed that the records were ready and would be submitted to the petitioner shortly, as the entire staff of the office has been engaged in flood duty. The Commission therefore, directs the Secretary of Moirabari Gaon Panchayat to furnish the information sought for by the petitioner within 30 days from the date of receipt of this order through speed post or registered post.

With the above direction, the second appeal petition dated 30.1.2018 is disposed of.
