Smti. Tulika Kumari Das, SPIO, Directorate of Geology & Mining, Assam is present. She submitted a Written Statement with today's date.

The Appellant, Sri Harinarayan Pathak is present.

Through her Written Statement and personal deposition, the SPIO submitted that the information had been furnished through a letter dated 05.01.2019. She added that the letter had been delivered by a Special Messenger and received by a family member of the Appellant. She has enclosed copies of all the documents for evidence.

The Appellant submitted that he had not received the said letter containing the information. He accepted the copy of the letter which was handed over by the SPIO during the hearing. After scrutinizing the documents he submitted that the copy of the complaint letter of Mr. Akheer Langthasa received in the office on 21.09.2018 was both unclear and partially cut while photocopying. He further stated that according to the copy of the Dak Register provided by the SPIO indicated that the letter in question no. 5586 had been cancelled out from it signifying that the same was not delivered.

It is indeed seen that the said complaint letter was not fully legible and the right side of it was incomplete.

Considering the submission by the Appellant, **the Commission hereby directs the SPIO to furnish a better photocopy by duly authenticating it to the Appellant within 10 days of receipt of this order.**

With this, the Second Appeal is hereby disposed of.
