**O R D E R**

Sri Homen Kakati, Secretary, FAAMCH, Barpeta on behalf of the SPIO is present.

The Appellant absent.

Perused the case record. The Second Appeal dated 07.06.2019 was submitted by the Appellant stating that he had not received the information he had sought for through his RTI Application dated 11.03.2019 inspite of having submitted his First Appeal dated 22.04.2019 to the Principal-cum-Chief Superintendent, Fakhruddin Ali Ahmed Medical College & Hospital, Barpeta on 22.04.2019. Through his Application the Appellant wanted to know (i) The cut off marks for selection, (ii) Marks obtained by the applicant, (iii) Certified copy of evaluated answer script, (iv) Answer key used to evaluate OMR, (v) Time and place where answer scripts were inspected. The queries related to Gr-IV/Class Workers Written Test.

A Written Statement dated 16.09.2019 had been received from the SPIO/Superintendent, FAAMCH. It was submitted that the RTI Application was received on 30.03.2019. The Appellant was replied to through a letter dated 30.03.2019 stating that the information could not be disclosed as the appointment process was not complete. Thereafter, a pointwise information along with copies of relevant documents were furnished through a letter dated 21.05.2019 by Ordinary Post.

The SPIO's depute submitted that the information was sent to the Appellant through Ordinary Post for the reason that the number of RTI Applications received by the SPIO was significantly high and therefore furnishing of information through Registered Post in each case was beyond the budget of the institution.

Considering that the communication from the SPIO is stated to have not been received by the Appellant, **the SPIO is hereby directed to provide another copy of the communication to the Appellant by a reliable means including by Registered Post, if possible, within 10 days of receipt of this order.**

**With this, the Second Appeal is hereby disposed of.** Sd/-
