Sri Shantanu Barua, AFS/SPIO, Nagaon Forest Division is present. A Written Statement dated 17.09.2019 submitted by the SPIO.

The Appellant has sent a written apology with today's date and a request to provide access to the information he had sought for.

Heard the SPIO and perused the Written Statement along with its enclosures. It is seen that in response to the RTI Application dated 31.05.2018 received on 01.06.2018 the Appellant was requested through a letter dated 03.07.2018 to collect the information from the office. The said letter was dispatched by Ordinary Post. The SPIO submitted an authenticated copy of the page of the Dispatch Register containing Sl. No. 91 as evidence of the dispatch. The SPIO explained that the information/documents were voluminous and that the Appellant had not responded to the said letter.
