The Appellant is absent without information.

Perused the Written Statement and heard the SPIO and his assistant. It has been submitted that the RTI Application dated 10.10.2017 was received on 24.10.2017 and transferred to the SPIO, Panchayat & Rural Development Department through a letter dated 18.11.2017 with reference to the forwarding of the Appellant's earlier representation dated 14.03.2017 to the said Department by Dak on 21.03.2017. He added that it was now for the SPIO of that Department to furnish the information.

In view of the submission by the SPIO, **the Commission hereby orders that the SPIO, Panchayat & Rural Development Department shall furnish the information to the Appellant, if not already furnished, free of cost, within 15 days of receipt of this order.**

The Second Appeal is hereby disposed of. The Appellant shall be at liberty to submit a fresh First Appeal to the appropriate First Appellate Authority of Panchayat & Rural Development Department if he is not satisfied with the action taken or lack of action by the SPIO of that Department.
