The Petitioner Sri Dulal Bora is absent.

The Public authority is represented by Sri Golok Ch. Bora, SPIO, SEBA, Academic Officer and Sri Ajit Kr. Patowary, ASPIO, Audit Officer, SEBA.

The SPIO, SEBA Sri Golok Ch. Bora stated that the complaint petition filed by Sri Dulal Bora dt. 24-2-2017 could not be traced in their office and that the Pin code mentioned in the Speed post was not correct. He mentioned that he had received the complaint petition along with the notice for hearing on 17-1-2018 sent by the Commission and requested for time for furnishing information with reference to matters related to SEBA. He however stated that the complaint petition was also related to **RMSA** and Department of Education, Govt. of Assam and as such the same would be transferred to the Authorities concerned for furnishing of information to the petitioner.

The Commission therefore directs the Public authority to furnish the information sought for by the petitioner within 21 days from the date of receipt of this order and transfer the matter not related to them to the concerned authorities for furnishing of information within 21 days from the date of receipt of this order.

With the above aforesaid order the 2nd Appeal petition dt. 17-11-2017 is disposed of.

The Petitioner Sri Dulal Bora is absent.

The Public authority is represented by Sri Kshitish Ch. Pegu, ACS, Joint Secretary to the Govt. of Assam & SPIO, Panchayat & Rural Development Deptt.

From perusal of Case record it is seen that the petitioner filed a complaint petition dt. 12-12-2016 against Sri Bhaskar Baruah, Jr. Engineer, Panchayat & Rural Dev. Deptt., Lakhimpur District. The complaint petition was addressed to the Addl. Chief Secretary to the Govt. of Assam, Panchayat & Rural Dev. Deptt. It was also followed by an RTI petition dt. 27-3-2017 seeking for the following information.

- The File No. from which the enquiry was ordered, name of the Enquiry Officer and present posting of the officer,
- Name & address of the accused person and
- Copy of the Enquiry Report.

The RTI petition was followed by his 1st Appeal petition dt. 24-7-2017 addressed to the PIO, O/o the Addl. Chief Secretary to the Govt. of Assam, Panchayat & Rural Dev. Deptt. and the instant 2nd Appeal petition dt. 18-11-2017.

The SPIO and Joint Secretary, Assam, Panchayat & Rural Dev. Deptt. has submitted a written statement dt. 13-1-2020 which is entered into Case record. It has been mentioned in the written statement that no enquiry was ordered on the complaint petition dt. 12-12-2016 regarding service matter of Sri Bhaskar Baruah. In this regard necessary information has been forwarded to the petitioner vide letter dt. 21-2-2017 & 12-4-2017. The petitioner was also called for hearing for the 1st Appeal 3 times vide letter dt. 5-1-2018, 9-2-2018 & 9-4-2018, but there is no record of hearing. However necessary information pertaining to service matter of Sri Bhaskar Baruah is being forwarded again for favour of information of the petitioner.

In view of the above, it appears that no enquiry was held on the complaint petition submitted by the petitioner on 12-12-2016. and the Public authority informed the petitioner accordingly. Therefore non-receipt of information on the RTI petition does not arise. The 2nd Appeal is disposed of .
