The petitioner stated that he had not received any communication from the BDO, Sisiborgaon Dev. Block.

The Commission observes that the information sought for relates to 17 Gaon Panchayat Secretaries. The Commission therefore advises the petitioner to file separate RTI petitions to the Gaon Panchayats concerned.
