## <u>ORDER</u> 30-8-2019

The petitioner Sri Harinarayan Pathak is present.

The Public authority is represented by Sri Hitesh Sarma Medhi, Asstt. Executive Engineer, SPIO, G.M.D.A., Assam. He has submitted an action taken report on the Appeal petition submitted on 14-5-2018. He stated that the petitioner Sri Harinarayan Pathak submitted an RTI 1<sup>st</sup> Appeal in the office of the GMDA on 14-5-2018 seeking information regarding transfer of his RTI application from the O/o the Registrar of Firms & Societies, Assam vide letter dt. 22-3-2018. On receipt of the same he informed the petitioner Sri Harinarayan Pathak vide letter dt. 28<sup>th</sup> May, 2018 that no letter dt. 22-3-2018 had been received till date and he may furnish the RTI application to the SPIO for necessary action. Subsequently the petitioner submitted an Appeal petition on 7-6-2018 enclosing his RTI petition regarding copy of occupancy certificate issued from GMDA with respect to building permission in which the Registrar of Firms & Societies, Assam is running on rent. The petitioner was informed vide letter dt. 30<sup>th</sup> July, 2018 that no record of any building permission/land permit proposal has been marked in the name of Sri Rongkomon Warisa in the computerized database maintained by the Authority since 2008. He was however advised to inspect the manual record of building permission prior to computerization on prior intimation. The SPIO also orally submitted that without any specific File No. or any document in this regard it would not be possible to furnish the information.

The petitioner present stated that he has inspected the manual records in the office of the GMDA and could not trace any document till date. He said that he had no objection relating to non-receipt of occupancy certificate, as he could not submit any reference in this regard but objected that he is yet to receive information from the Registrar of Firms & Societies, Assam on point No. 2 to 5 of his RTI petition dt. 12-2-2018 from the SPIO, O/o the Registrar of Firms & Societies, Assam.

The Commission therefore directs the SPIO, O/o the Firms & Societies, Assam to furnish the information sought for by the petitioner within 21 days from the date of receipt of this order.

With the above direction the 2<sup>nd</sup> Appeal petition dt. 14-5-2018 is disposed of.
