ORDER 30-5-2019

The petitioner Sri Bijoy Barhoi is present. The Public authority is represented by Smt. Aibheelata Boro, Principal, I.T.I., Tezpur assisted by Sri Biju Kumar Tanlrabary Sr. Assistant, I.T.I.

The petitioner complained vide letter dt. 30-8-2018 that he was not furnished copies of documents of the Workshop Attendant appointed and he had apprehension that these 2 selected candidates did not have any Trade Certificate.

The Public authority clarified that the Trade Certificate was not compulsory as per Guidelines issued by the Directorate of Employment & Craftsmen Training, Assam. Besides advertisement issued for appointment of selection of Workshop Attendant at Tezpur I.T.I. on 31st December, 2011 the minimum educational qualification required was Class VIII pass and desirable was familiarization with I.T.I., Tezpur. Based on the guidelines the Selection Committee constituted by the Deputy Commissioner, Tezpur vide letter dt. 18-4-2012 selected and recommended the 2 candidates for the post of Workshop Attendant.

The Commission is of the opinion that public interest in disclosure of information sought for, outweigh any right to privacy, as the matter relates to the appointment of Government employees. Since public interest outweighs any harm done to protected interest U/S. 11(1) of the RTI Act, the Commission directs the SPIO, the Principal, Industrial Training Institute, Tezpur to furnish photocopy of the information sought for by petitioner within 15 days from the date of receipt of this order.

With the above direction the 2nd Appeal petition dt. 8-1-2019 is disposed of.
