ORDER 30-4-2019

The petitioner Md. Ketab Ali is present. The I/c Inspector of Schools, DDC, Dhubri vide mail dt. 29-4-2019 has informed that the RTI petition filed by the petitioner dt. 9-7-2018 was transferred to the Head Master, Gutipara High School on on 12-7-2018. Thereafter on receipt of Appeal petition on 8-2-2019 the 1st Appeal petition was disposed of on 16-3-2019 which was attended by the respondent, but the petitioner was found absent. The Head Master Gutipara High School was directed to provide the required information to the petitioner within 7 days free of cost and the matter was disposed.

The petitioner stated that he was furnished the information on 27th September,2018, but he was not satisfied with the reply furnished by the Head Master and furnished a copy of the reply which is taken into Case record.

On perusal of the reply furnished to the petitioner present, it is seen that pointwise reply to his RTI petition had been furnished. He objected that the same were only photocopies and not certified. The Commission therefore directs the petitioner to visit the office of the Head Master, Gutipara High School within 10 days from the date of receipt of this order and the Head Master, Gutipara High School is directed to authenticate the document furnished to the petitioner vide letter dt. 27-9-2018.

With the above direction the 2^{nd} Appeal petition dt. 2-10-2018 filed by the petitioner is Sd/disposed of.
