<u>ORDER</u> 29-7-2019

The petitioner Sri Anowar Hussain is absent. The Public Authority is represented by Sri Ashok Kairy, S.A., O/o the Deputy Inspector of Schools, Silchar as authorized by the Deputy Inspector of Schools, Silchar.

The Deputy Inspector of Schools, Silchar has submitted a written statement dt. 26-7-2019 that the information sought for by the petitioner on 6 points of his RTI petition dt. 5-8-2017 was held by the Head Master of the respective School. Besides all kinds of fund were transferred by SMO directly to the A/C of SMC of each School. Considering the above facts he had requested the petitioner Sri Anowar Hussain vide letter dt. 12-12-2017 and discussed on the matter. He also issued instruction to all the Head Masters/ Head Teachers of Silchar Block to provide information directly to the petitioner vide letter dt. 29-6-2018. He also mentioned that as per memorandum dt. 20-11-2013 issued by the Ministry of Personnel Public Grievance Pension Deptt., "it was observed that some applicants seek information Officer as well as the applicant. The applicant should therefore see to it that by way of one application, he seeks information in respect of one subject only".

The Commission observes that the petitioner sought for various information pertaining to all provincialised L.P. Schools, upper Primary, M.E. School, M.V. School, Sr. Basic School, Jr. Basic School, Pre Sr. Madrassa etc. of Cachar District in a single RTI petition. The Commission therefore directs the petitioner to submit individual RTI petition to the respective head of the School for which the information is required.

With the above direction the 2nd Appeal petition dt. 23-1-2019 is disposed of.
