## ORDER 29-3-2019

The Public authority, Secretary to the Govt. of Assam, Welfare of Minority & Development Deptt. and 1<sup>st</sup> Appellate authority has informed that the RTI petition dt. 20-8-2018 was transferred to the Deputy Commissioner, N.C. Hills, Dima Hasao & Karbi Anglong Dist. to furnish the required information to the petitioner directly. On receipt of the 1<sup>st</sup> Appeal petition dt. 11-10-2018 as per order of the 1<sup>st</sup> Appellate authority WMD Deptt. the Appellant was informed that the RTI petition has been transferred to the Deputy Commissioner, N.C. Hills, Dima Hasao and Karbi Anglong Dist. vide letter dt. 14-11-2018.

The petitioner Sri Indra Rangphar vide letter dt. 25-3-2019 has informed the Commission that he has not received the requested information from the SPIO, O/o the Deputy Commissioner, N.C. Hills, Dist. Dima Hasao till date and has enclosed a copy of the letter sent to him by the Addl. Deputy Commissioner, Karbi Anglong Dist. dt. 8<sup>th</sup> February, 2019 furnishing the information.

The Deputy Commissioner, Dima Haso, Dist. Haflong has deputed Sri I. Teron, ACS, Asstt. Commissioner, Dima Haso, Haflong to attend the hearing along with relevant papers and documents relating to the RTI petition submitted by Sri Indra Rangphar. The Addl. Deputy Commissioner and PIO, Dima Haso Dist. has informed the Commission that the Deputy Commissioner, Dima Hasao did not receive any RTI application from Sri Indra Rangphar nor any official correspondence was received from the Welfare of Minority & Dev. Deptt., Guwahati. However, RTI reply as sought for by the petitioner received vide Commission's notice under reference, has been furnished. A copy of the same has been marked to the petitioner. Sri Ibon Teron verbally stated that the information was sent to the petitioner through Registered Post on 28<sup>th</sup> March, 2019.

The Commission observes that the information sought for by the petitioner has been furnished by the Deputy Commissioner, Dima Hasao Dist. as well. As such the 2<sup>nd</sup> Appeal petition dt. 24-12-2018 is disposed of.
