**O R D E R**

1. The public authority i.e. the SPIO of the Tourism Department is represented by Smti Geeta Kundu Chakraborty, SPIO and Deputy Secretary of the Tourism Department accompanied by Sri Bidyarnav Bora, SPIO of Directorate of Tourism and Sri M. Hazarika, Tourist Information Officer of the Directorate. The SPIO of Tourism Department has submitted a written statement dated 9.6.2020 with enclosures stating that the petitioner was intimated about the cost of the documents he has sought for vide his RTI petition dated 27.11.2018 but no response has been received from the petitioner till date.
2. The petitioner Sri Dadul Bharali has sent an e-mail dated 9.6.2020 which was received on 10.6.2020 at 10.30 AM stating that he will not be able to attend today's hearing due to physical health issues/ problems of his mother-in-law. Neither the petitioner has mentioned the cause of health issues of his mother-in-law nor any supporting medical document is enclosed.
3. Since, the SPIO and other officers are present in today's hearing and submitted a written statement, the second appeal petition dated 19.1.2019 is disposed of with a direction to the petitioner to collect the sought for documents from the office of the SPIO of the Tourism Department if he so desire after bearing the necessary cost.
4. The instant second appeal petition dated 19.1.2019 read with RTI petition dated 27.11.2018 is disposed of and no further correspondence seem to be necessary in this matter.
