O R D E R

10.06.2020

1. The SPIO of the office of the Director of Agriculture, Khanapara in response to this Commission notice no. SIC/KP(M)868/2019/9 dated 3-6-2020 did not attend today's hearing and failed to intimate the cause of his absence. The SPIO is to be issued notice under section 20(1) of RTI Act 2005 as to why no penalty should be imposed on him for his non attendance at the Commission in response to the notice dated 3-6-2020.
2. From the e-mail dated 10.6.2020 of the petitioner it is seen that a part of the information has been furnished to him and for the rest of the information the SPIO vide letter no. Agri/Esstt/8062(RTI)/Pt-IV/Vol-I/2018-19/137 dated 01-04-2019 has transferred the case to the Nodal officer, RKVY/BGREI/ NFSM/NMOP/ PMKSY/RKVY/NAEP/ SHM/Org.Farming/ SMAM/RIDF for furnishing the information. But there is no intimation from the Nodal Officer. The Nodal Officer is directed to explain his silence on the date of hearing i.e, on 10-06-2020
3. The petitioner Sri Joydeb Das sent an email dated 10-06-2020 stating that he cannot attend hearing due to his illness. Nothing is mentioned about his illness and no medical certificate is attached. Since he is given enough time to appear at the hearing, it will not be prudent to give him any further time for hearing as thousands of cases are pending at the Commission.
4. Since the petitioner himself is casual on his attending the Commission without any compelling and explained medical reason including absence of medical certificate, the instant 2nd appeal petition dated 17.8.2019 is disposed of.
