**O R D E R**  
30.01.2020

The petitioner Sayeed Hussain Mazumder is present. The public authority is represented by Sri Gautam Singha, Assistant Teacher, Sirajul Ali Higher Secondary School, Barjatrapur, Cachar.

The Principal, Sirajul Ali H.S. School has furnished the information sought for under the RTI Act, 2005 to the Inspector of Schools, CDC, Cachar with copy to the Commission and the petitioner. The particulars of informations furnished were as follows :- (1) Mehzabeen Choudhury, M.Sc, B.Ed, Assistant Teacher (Science), (2) Ashraful Haque Mazumder, M.Sc. B.Ed. (Contractual Maths. Teacher). He mentioned that the personal information sought for cannot be disclosed under Section 8(i)(j) of the RTI Act, 2005. He also stated that he could not attend the hearing today on medical ground.

The petitioner present stated that he has not received any paper from the Principal of Sirajul Ali Higher Secondary School. The Diarist of the Commission handed over a copy of the letter dated 24.1.2020 to the petitioner and the same is received by him. The petitioner present objected that when he submitted his RTI petition there was another Maths. Teacher of the said Higher Secondary School, viz., Sri Buddhadev Choudhury, who is now the Principal of the Higher Secondary School and his educational qualification has not been furnished. He also raised objection that certified copies of the appointment letters along with educational qualification and mark sheets etc. were not furnished. The Principal has mentioned that personal information cannot be disclosed under Section 8(i)(J) of the RTI Act, 2005.
