The petitioner Sri Joydeb Das is present. The public authority to be represented by the SPIO of the Directorate of Agriculture is absent. However, the SPIO & Joint Director of Agriculture (PP) has submitted a written statement dated 2.3.2020 which is entered into the case records. The Registry of this Commission is directed to furnish the copy of the WS along with the enclosures submitted by the SPIO to the petitioner.

The petitioner submitted an application dated 5.3.2020 stating that the SPIO has not furnished the full information, as sought for vide his RTI petition dated 13.2.2019. He has mentioned in his application dated 5.3.2020 that in respect of the districts of Barpeta, Baksa, Bongaigaon, Kokrajhar, Goalpara, Dhubri, South Salmara, Dibrugarh, Nalbari, Kamrup (R), Kamrup (M), Cachar, Karimganj, Hailakandi, Karbi Anglong and Dima Hasao no report has been furnished.

The Commission, therefore, directs the SPIO to obtain the required information from the concerned districts and furnish the sought for informations directly to the petitioner at the earliest.

With the above direction, the 2<sup>nd</sup> appeal petition dated 1.7.2019 is disposed of.
